



4. No Tender will be accepted below 3 % rate of the Tender value.
5. Detailed particulars may be seen in the office of the undersigned & which may be collected from office during offices hours from 10 A.M to 4 P.M if required.
6. The undersigned reserve the right to reject any tender in full or in part without assigning any reason thereof.
7. The undersigned is not bound to accept the lowest tendered.
8. The current registration No. and Name of Govt. Department must be noted very clearly.
9. Full name and address of the tenderer should be mentioned very closely.
10. Once the tender is opened and accepted, no request to enhancement of rate will be honoured.
11. The contractor will be fully responsible for any loss or damage of the materials.
12. The Contractor at his expense to make of any good structure damaged in the course of execution of the works.
13. All kind of Tax like GST, IT, FR etc whatever applicable will be reimburse from the bill if the contractor unable to produce the appropriate tax / GST paying receipt.
14. 8% security money will be deducted from the bill and it will be refundable after satisfactory completion of defect liability period of 6 (six) months.


