9. Once the tender is opened and accepted, no request to enhancement of rate will be honoured.
10. The contractor will be fully responsible for any loss or damage of the materials and the value of the materials will be recovered double the cost of issue rate of the undersigned department from the contractor.
11. The Contractor at his expense to make of any good structure damaged in the course of execution of the works.
12. All kind of Tax like GST, IT etc whatever applicable will be reimburse from the bill if the contractor unable to produce the appropriate tax / GST paying receipt.


