6. The undersigned is not bound to accept the lowest tendered.
7. The current registration No. and Name of Govt. Department must be noted very clearly.
8. Full name and address of the tenderer should be mentioned very clearly.
9. Once the tender is opened and accepted, no request of enhancement of rate will be honoured.
10. The contractor will be fully responsible for any loss or damage of the materials and the value of the materials will be recovered double the cost of issue rate of the undersigned department from the contractor.
11. The Contractor will at his own expense to repair any damaged structure in the course of execution of the works.
12. All kind of Tax like GST, IT, Labour Cess etc. whatever applicable will be deducted from the bill if the contractor unable to produce the appropriate tax / GST paying receipt.
13. Contractor should submitted the online payment receipt of Forest Royalty to the under signed office before preparation of bill.
14. Labour license, GST number and income tax clearance certificate for the last one year must be submitted along with the tender.
15. 8% security money will be deducted from the bill and it will be refunded after satisfactory completion of the defect liability period of 6 (six) months.
16. The work must be completed within stipulated period. Otherwise the undersigned reserves the right to cancel work order without making any payment to the contractors.


